NOTICE

Whereas, the NGO namely Ankita Bal Vidhya Mandir Shiksha Samiti, Kota, Rajasthan has been receiving financial assistance from time to time from this Ministry under the Scheme of Assistance to Voluntary Organizations working for Welfare of Scheduled Castes for running of Residential Primary School for Scheduled Caste beneficiaries in Kota, Rajasthan.

- 2. Whereas, the Scheme aims to enhance the reach of development interventions of the government and fill the gaps in the service deficient Schedule Caste dominant areas, in the sectors such as education, health, vocational training etc through the efforts of voluntary organizations and to provide an environment for socio economic upliftment and overall development of Scheduled Castes (SCs).
- 3. Whereas, the said NGO has executed bonds in favor of the President of India for the amount in the prescribed format bonding themselves jointly, severely to the terms and conditions in the event of the grantee failing to comply with the conditions committing breach of the conditions of the bond, the signatory to the bond shall be jointly and severely liable to re-fund President of India, the whole or a part amount of the grantee with interest at the rate of 10 percent per annum therein or the sum specified under the bond.
- 4. Whereas, the Grantee Organization was required to abide by the terms and conditions mentioned in the Sanction Order, provisions and guidelines of the Scheme of Grant-in-Aid to Voluntary Organizations working for Scheduled Castes, provisions of General Financial Rules, 2017, instructions issued by this Ministry and Department of Expenditure, Ministry of Finance from time to time and any subsequent revision/changes therein.
- 5. Whereas, Government of India conducted inspection of the School run by Ankita Bal Vidhya Mandir Shiksha Samiti, Rajasthan on 21.07.2017 & 22.07.2017 and during the inspection it was observed that there are many irregularities which are violative of the Scheme. The infrastructure of the School was found to be poor. The inspection team observed that the School authority seems to be running the school in a very lackadaisical and insensitive manner. The walls are damaged & unplastered and the same may not have been repaired for quite some time. Some of the windows are without panes and covered with plastic sacks/bastas. The condition

of the single toilet used for both boys and girls was unclean and unhygienic. No adequate Sports equipment were there. No proper cooking facilities were present. The motive of the NGO in establishing the School and the way it is being run, leads to a lot of suspicions.

- 6. Whereas, a Show Cause Notice dated 21.09.2017 was served on the organization for seeking explanation for the shortcomings/findings as observed during the inspection and as mentioned in preceding paras.
- 7. Whereas, it was stated that the Grantee Organisation may be blacklisted in case, it is found at any stage that they had received Grand-in-Aid under the above Scheme on the basis of suppression of facts, misleading information, fabricated document and false information.
- 8. Whereas the Organization has submitted its reply dated 15.10.2017 and denied all the shortcomings pointed out by the Inspection team. In the reply, the organisation stated that there was a repairing works going on in the school wherein the walls are being plastered and repaired there is a provision for separate toilets for students. Provision for sports equipments are made. Also stated that Cooking facilities were improved. The NGO has not sent any photographs or any other proofs to substantiate the claim that it has made necessary improvement.
- 9. Whereas, Competent Authority and the reply of the organisation having considered the shortcomings in the inspection 19.7.2017 and 20.07.2017, observed there is clear violation of the provisions of the Scheme especially the breach of trust.
- 10. Now, Keeping in view of all the above mentioned facts especially with regard to the utilization of GIA, it has been decided, after following principle of Natural Justice & giving opportunity to the NGO, by the competent authority in public interest to blacklist the Organization namely Ankita Bal Vidhya Mandir Shiksha Samiti, 38- Royal City Bajrang Nagar, Kota, Rajasthan, Pin Code- 324005, from receiving further financial assistance in any form whatsoever under various Schemes of this Ministry.



11. This order is issued without prejudice to any other action that may be initiated against the NGO for their action of omission and commission, without any further reference in the matter.
