

**ORDER**

1. WHEREAS, the NGO namely Andhra Pradesh Girijana Sevak Sangh Nandigama, Krishna District, State (Andhra Pradesh) has received assistance in the form of Grant-in-Aid from this Ministry under the Scheme of Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse from the year 1998-99 to 2007-08.

2. AND WHEREAS, the CBI Report in PE. 5(A)/2010-CBI/Hyd dated 11.07.2011, in which, CBI Enquiry revealed that the main allegation against the NGO is that the Schemes were shown on paper without implementing the same and the inspection reports and the recommendation letters in the name of Govt. of Andhra Pradesh officials were forged and fabricated by the representatives of the NGO.

3. NOW THEREFORE, after considering all the facts of the matter and going through the details of the case, it is noted that the NGO has violated the terms and condition of scheme guidelines which is a serious lapse on the part of the NGO. Accordingly, the NGO namely Andhra Pradesh Girijana Sevak Sangh Nandigama, Krishna District, State (Andhra Pradesh) is hereby blacklisted for receiving any grants from Government of India.
