

**MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 8<sup>th</sup> July, 2020 TO CONSIDER NEW PROJECT PROPOSALS UNDER THE IPSrC component of NAPSrC FOR THE YEAR 2020-21.**

The meeting of the Screening Committee of Social Defence Bureau was held on 8<sup>th</sup> July, 2020 through Video Conference under the Chairpersonship of Additional Secretary (SJE) (Ms. Upma Srivastava) to consider the new project proposals under the component of Integrated Programme for Senior Citizens (IPSrC) of the National Action Plan for Senior Citizens (NAPSrC). Deputy Secretary (Sr.C) was asked by the Committee to assist them during the meeting.

2. The Committee comprising Shri S.B.Jain as Member and Shri P. K. Tamarkar, Director (IFD) and Principal Secretaries/Secretaries/Directors or their nominees from the State/UT governments (as per Annexure-1), as Members, considered a total of **1314 online new** project proposals for the year 2020-21. Shri Pankaj Kochar, Member did not attend the meeting for technical reasons. Details of the proposals which were considered by the Screening Committee are given in the **Annexure-II**. Out of the 1314 proposals 380 were rejected on the ground of being deficient in necessary documents or not fulfilling the parameters as mentioned below:



**A. Parameters:**


1. Organisation should have working experience of two years
2. Activity should be included in the Memorandum of Association of the organization, and
3. Organisation should have uploaded two years Audited Accounts, Annual Reports of the organization and other relevant documents

3. The Committee had a target of recommending 250 proposals as per the pre decided AAP 2020-21 and at least 30 reserve proposals which would be operational in the event when any adverse report is received from the States/RRTC in respect of proposals recommended by the Screening Committee. For selection of these projects, the Committee adopted the following criteria for recommendation of new project proposals:

**Criteria:**

1. Selection in a given State/UT will align with number fixed for that State/UTs in the AAP 2020-21. However, the committee may increase/reduce/adjust the number of new proposals to be recommended for each State/UT, in view of number of completed proposals received and requirement of projects etc in the States/UTs.
2. The Screening Committee shall accord first priority to projects of 50 mix gender beneficiaries for uncovered Districts in accordance with the AAP for 2020-21 and second priority was given to Senior Citizen Homes for 50 elderly women for uncovered/covered districts subject to availability of proposals.



3. Screening Committee shall have power to convert the project of any organization from SrCH for 50 elderly women to SrCH for Mix gender beneficiaries for uncovered Districts as provision for applying for 50 mix gender proposals was not available in portal.
4. Not more than two proposals of an organization shall be recommended in a State.
5. State recommended cases shall be mandatorily selected.
6. Priority shall also be accorded to the projects of SrCH for disabled Sr. Citizens
7. Project of Continuous Care Homes/ Homes for Alzheimer's/Dementia patients shall be recommended to the organizations, which have Medical institutions/Hospitals/ Nursing Homes etc, as per the scheme guidelines.
8. New Proposals for Mobile Medicare Units and Physiotherapy clinics shall not be recommended as these projects have to be sanctioned by the State Government under SAPSrC from 2020-21 onwards.
9. Projects of Regional Resource and Training Centre's shall be treated as deferred, as these proposals would be considered in due course along-with applications invited separately for the programme by the Department.

4. After scrutinizing the proposals, and in discussion with the State Government representatives, the Committee recommended the following 250 new project proposals of Senior Citizens Homes/ Continuous Care Home for 2020-21 under the component of Integrated Programme for Senior Citizens (IPSrC) subject to satisfactory inspection report of the State/UT Governments and/or Regional Resource and Training Centres of the Senior Citizen Division:-
