ORDER

1. WHEREAS, the NGO namely Social Transpermatation and Rural Technology, Ranga Reddy, Telangana has received financial assistance in the form of Grant in Aid from this Ministry under the Scheme of Assistance for Prevention of Alcoholism and Substance (Drugs) Abuse from the year 1998-99 to 2011-12.
2. AND WHEREAS, the project was inspected by the State Team on 21.09.2011. Inspection team vide its report dated 16.03.2012 pointed out that board of the organization was not displayed on the entrance of the organization. A closed small two tiny rooms on the upstairs of a residential cum commercial shop are said to be the office of this organization. There were no traces of functioning of any de-addiction centre in this small house.
3. AND WHEREAS, it was reported that the organization was not functioning for the last three years and salaries were not paid to the employees.
4. AND WHEREAS, it is clear from the report given by the State Team that the organization has not utilized the funds for which Grants-in-aid was released by the Govt of India.
5. AND WHEREAS, the centre was inspected by a team of officers from the Ministry on 28.04.2014 and observed that no recreation facility was available, no staff had undergone training for last two years, honorarium register, cash/ ledger book, bank pass book etc. were not available and the project location was changed without intimation.
6. AND WHEREAS, the centre was again inspected by an officer from the Ministry on 30.01.2015 and was observed that space is inadequate, cleanliness was lacking and quality of services were not at par.
7. AND WHEREAS, it has been established that the conditions incorporated in the Sanction Order has been violated by the NGO and consequential steps as per the following condition is warranted in this case namely;

"if the government is not satisfied with the progress of the project or considers that the conditions of the sanction are being violated, it reserves the right to terminate the grant-in-aid "

8. AND WHEREAS, the Chief Vigilance Commission vide its O.M. No.010/EDN/31849 dated 27.06.2016 para 2(iii) desired that since no details are available as to whether any criminal case has been filed against the organisation, the CVC henceforth advised the CVO of the Ministry of Social Justice & Empowerment to take up the matter with the police authorities to initiate criminal proceedings against the NGO, their officials and govt officials involved in the matter for releasing/receiving of govt. grants to/by the NGO.

9. NOW THEREFORE, after considering all the facts of the matter and going through the details of the case, it is noted that the NGO has violated the terms and conditions of scheme guidelines which is a serious lapse on the part of the NGO. Accordingly, the NGO namely Social Transperamation and Rural Technology, Ranga Reddy, Telangana is hereby blacklisted for receiving any grants from Government of India.
